**Each signatory identified below undertakes as follows:**

- 3.1 I have full authority and legal capacity to execute this authorization and have read and understand, or have had explained to me by a representative of the bank, the terms and conditions of this authorization. I further represent and warrant that I and together any other signatories below are the true and lawful owners of the Makaseb fund accounts indicated above, and that none of the Units to be redeemed under this authorization are subject to any pledge or otherwise encumbered in any manner.
- 3.2 I undertake to have a sufficient number of Units in my Makaseb fund account, as indicated above, in order to effectuate the exchange on the applicable Dealing Day. If there should not be sufficient number of Units in my Makaseb fund account on the applicable Dealing Day or if the redemption of such number of Units would not result in net redemption proceeds equal to at least the minimum subscription amount required by the second Makaseb fund, I release the bank and the applicable Makaseb Funds Companies from any responsibility for the failure to redeem Units from, and to subscribe for Units of, my Makaseb fund accounts.
- 3.3 I authorize the applicable Makaseb Funds Companies or their agents to redeem such Units from my Makaseb fund account as are indicated above and to invest the redemption proceeds, less applicable redemption fees and other charges, to subscribe for Units of my second Makaseb fund account as also indicated above.
- 3.4 I understand that this authorization, duly executed, must be received at least seven (7) Business Days before the Dealing Day applicable to the Makaseb fund account from which the amount will be redeemed, and that this authorization is irrevocable after it has been duly executed and submitted to the bank. I further understand that the exchange transaction between my Makaseb fund accounts will occur on the same day, provided the Makaseb funds between which the exchange will occur have the same Dealing Days, and if not, then the net amount of any redemption will be invested into the second Makaseb fund on the Dealing Day of the second Makaseb fund next occurring after the date of the redemption. I hereby waive any and all claims or demands for compensation for any delay between any redemption and any subscription under this authorization.
- 3.5 I agree that the bank and the applicable Makaseb Fund Companies will not incur any loss, liability, cost, or expense for acting, or for any failure to act, upon this authorization.
- 3.6 I agree that all terms and conditions of the Prospectus applicable to each of my Makaseb fund accounts indicated above apply in full to the respective redemption and subscription requested under this authorization. Capitalized terms used in this authorization have the same meaning as in the applicable Prospectus.
- 3.7 I understand and agree that the redemption requested under this authorization from my Makaseb fund account is subject to applicable redemption fees and, in addition, that I will be charged, by deduction from the redemption proceeds, a processing fee of \_\_\_\_\_.
